Executive Director Medeiros reported the following:

The Technical and Professional Advisory Committee (TPAC) has 2 vacant membership designees (one for District 2 and one for District 5). Recommendations should be sent to the Executive Director.

First 5 CA released the Child Signature Program Request for Applications (RFA) on February 17, 2012. San Diego is one of 8 eligible counties to apply due to our participation in the Power of Preschool program. It is estimated that by participating in the Child Signature Program we can augment our early learning programs by about \$3.4 million a year over a 3 year period for a total of about \$10.2 million.

The Commission will be receiving a presentation on the Strategic Plan, the Budget, and the 5 and 7 year Financial Plans at their April 2, 2012 meeting.

The AB 99 law suit appeal period ends on March 19, 2012.
