The RFP for the Quality Preschool Initiative was released October 17. Four new zip codes were added; City Heights, Golden Hills, and two zip codes from Southeast San Diego.

The water districts that are being considered for the fluoridation project are Olivenhain, Sweetwater and Oceanside.
