## First 5 Commission of San Diego February 9, 2015 Annual Appointment of Finance Committee Members

## Background:

On October 13, 2003 (Item 5), the Commission directed staff to form a standing Commission finance committee that minimally included the Commission's Executive Director and Operations Manager, a staff member from the County's Auditor and Controller's Office, a TPAC member with finance skills, a member of the business community, and a representative of the Commission Chair.

The Finance Committee has been meeting monthly since December 2003. On November 6, 2006 (Item 9) the Commission approved the Finance Committee Membership Policy F5C-017, which requires that the Finance Committee have a minimum of 5 and a maximum of 7 voting members. These members are to include:

- An Employee of the County of San Diego Finance and General Government Group
- An Employee of the County of San Diego Treasurer-Tax Collector's Office
- An Individual Identified by the San Diego Regional Chamber of Commerce
- An Individual from the First 5 Commission Technical and Professional Advisory Committee (TPAC)
- An Employee of the County of San Diego Health & Human Services Agency
- A CPA familiar with government and nonprofit contracting
- At-large appointment.

All appointments must be approved by the Commission no later than March of each year. The Chair and Vice-Chair are to be appointed for a two-year term in January of each odd-numbered year but no later than March.
