### 4. Executive Director Report

**Executive Director Medeiros reported:** 

#### Health

<u>Healthy Development Services (HDS)</u> received national recognition and visibility for the program's innovative approaches to treating children with mild to moderate developmental and behavioral concerns. HDS was presented the Bright Idea Award from the Harvard Kennedy School Ash Center for Democratic Governance and Innovation.

Sandra McBrayer requested more in depth information on Healthy Development Services and asked to have a presentation given at an upcoming First 5 Commission meeting.

Two programs from First 5 San Diego were chosen to present at the Zero to Three National Conference: Healthy Development Services, and Maternal and Child Health Program.

# Learning

First 5 San Diego submitted an application for the <u>Quality Block Grant</u> to the California Department of Education in partnership with the San Diego County Office of Education and was awarded 5.1 million dollars in funding.

The <u>Home Visitation Initiative</u> is off to a great start for FY 2014-15. First 5 San Diego has already processed over 600 families for Home Visitation services. San Diego County is the first county to receive "National Accreditation" in 2015 along with the American Academy of Pediatrics to train the Healthy Families America Model.

The new Snapshot of First 5 San Diego has been completed. (The Snapshot was handed out to those present.)

## Community

First 5 San Diego launched its <u>Parent Engagement & Early Literacy Campaign</u> in January 2015. The campaign encourages parents and caregivers to talk, read and sing to their baby, recommending 30,000 words each day and focuses on language milestones. The campaign will run through June 2015.

First 5 San Diego with The San Diego Food Bank just wrapped up the Holiday Food Drive and it was very successful.

#### Website Award

<u>First5sandiego.org</u> received the Web Marketing Association's 2014 Award for Outstanding Achievement in Web Development. The award is the premier award recognition program for Web developers and marketers worldwide.

### • Sponsorship/Community Events

First 5 San Diego sponsored and had a booth at the Fresh Start Healthy Lifestyles Fair, hosted by the C5 Athletics Foundation on January 10, 2015.

#### Dashboard

Executive Director Medeiros presented the 1<sup>st</sup> Quarter FY 2014-15 Dashboard. Each quarter, staff prepares a dashboard of the key measures for each of the Commission's initiatives and major projects. The Dashboard shows that all key measures are *at* or *near* target.

A presentation on the Mi Escuelita Program was given by Danielle L. Fettes, Ph.D.

#### Administration

Stephen Magruder, Senior Deputy County Counsel, is retiring at the end of March this year and Kyle Sand will be his replacement.
