Executive Director Arguilez reported the following:

The San Diego County of Education has been selected to present at the First 5 California 2018 Child Health, Education, and Care Summit in April. They also were chosen to present at the July 2018 BUILD and QRIS National Meeting.

The YMCA Childcare Resource Service (YMCA-CRS) continues to recruit and train new family child care providers on using developmental screening tools. They have also received positive feedback from home visitors across the county on the newly-developed Supporting Families Guidebook, a resource guide that gives home visitors, as well as the families, the tools to make the best choice in choosing a quality early care and education program.

First 5 San Diego's public education campaign continues to run intermittently through June 2018. The campaign promotes early childhood literacy and encourages parents to Talk, Read, Sing and be active with their children. Staff are currently exploring event opportunities in the community.

The University of California at San Diego (UCSD) Center for Community Health has recruited 17 Family Child Care Homes and 4 Child Care Centers for the implementation of breastfeeding-friendly policies and lactation accommodation.
