Executive Director Arguilez reported the following:

- Mountain Health and Community Services, one of the Oral Health Initiative providers, opened their second dental site in Campo in July 2018. We will be monitoring in terms of outreach to children and pregnant women in the Native American community.
- First 5 has been working in conjunction with the San Diego County Office of Education (SDCOE), YMCA Childcare Resource Services, and others that are part of a consortium in San Diego that will ensure that we are demonstrating our impact in San Diego County so that the California Department of Education continues to fund these initiatives and support efforts that we know are so important for our youngest children. First 5 will be 1 of 16 counties that will be engaging in a pilot study in dual language learning. This is a great opportunity for the County to understand demographics and languages.

- First 5 is engaging in discussions locally and regionally about the future financial climate in terms
  of collaborating intentionally around the work we know is important. There was a meeting with
  San Diego Grantmakers and the Early Education Funders Committee to identify priorities and
  make sure that First 5 is at the table. After 20 years, First 5 is now seen as a collaborator,
  partner, and convener and will continue to strive to leverage our local and state resources.
- \$13.8M was recently invested in early childhood education by the San Diego Foundation. This is an opportunity to navigate that space by virtue of the work in Strong Families / Thriving Communities. Executive Director Arguilez is on the working committee for this effort and is honored to make connections on behalf of First 5 San Diego as it relates to the upstream work that Dr. Wooten spoke of and ensuring that we're not only looking at intervention but also looking at prevention to affect the trajectory change for our children.
- Executive Director Arguilez will be chairing the March for Babies on April 27, 2019 in partnership with the March of Dimes.
- The dashboard for the fourth quarter of FY 2017-18 is included in the Executive Director's monthly report in your binders.
- First 5 has been looking at how to strategize the prenatal component in Oral Health. We will be following up with the County Dental Officer, Dr. Olinger, and Dr. Coleman to strategize on increasing our engagement. In addition, Executive Director Arguilez recently had a meeting with Dr. Green of California Children's Services, which serves over 13,000 children and families throughout the county, to explore a possible partnership to bring the First 5 public campaigns to all CCS reception areas and referral pathways for families served.
