County Evaluation Summary

Evaluation Activities Completed, Findings, and Policy Impact

First 5 San Diego has a core design for five major projects that includes: process numbers, targeted outcomes and contextual information gathered through client feedback and provider input. Each project tracks service counts and demographics for clients served in addition to the following: 1. Oral Health: OHI tracks screenings, examinations and treatment for children and pregnant women; care coordination services; oral health education for parents, pregnant women and providers; and training for OBGYN's, pediatricians and dentists. 2. Healthy Development Services: HDS tracks service for children and families receiving parent education, care coordination, and screenings, assessments and/or treatment for behavior, development and speech/language concerns. 3. Quality Preschool Initiative: QPI tracks rates of child developmental screenings. Parent development and involvement is measured through a parent satisfaction survey. Teachers report on the academic degrees is obtained annually. Finally, QPI assesses classroom quality. 4. KidSTART: KidSTART Center tracks gains measured for children with multiple, complex disorders using the Vineland Adaptive Behavior Scale. 5. First 5 First Steps: F5FS tracks services for children and pregnant women. Various tools are used to measure parenting skills, overall safety and developmental appropriateness of the home environment, and children's health and well-being. There are 220,967 children ages 0-5 in San Diego County. First 5 San Diego programs intensively served 29,895 children, 10,786 parents and caregivers, and 1,365 providers (unduplicated counts). Latino children (64.2%) and parents/caregivers (57.2%) were the most prominent group intensively served, followed by White non-Hispanics children and parents/caregivers (12.8% and 17.2% respectively). HDS served 11,237 unduplicated children. Classes, consultations or therapy were provided to 8,202 caregivers. QPI provided 2,264 children a quality preschool experience. Within QPI, 10,355 children received a developmental screening, 1,979 parents received education, and 23 teachers and administrators earned a college degree. Nearly all QPI parents (99.1%) reported being satisfied or very satisfied with the quality of the QPI program. 209 children with complex needs received assessments and/or treatment or were connected to treatment services for multiple behavioral and/or developmental concerns via KidSTART. Through OHI, 12,877 children and 1,960 pregnant women received oral health screenings; 12,792 exams for children and 1,582 exams for pregnant women were performed. Close to 100% of high-risk children and pregnant women with dental disease received treatment. F5FS provided services to 555 caregivers/pregnant women and 493 children. 74.0% of mothers receiving F5FS services reported breastfeeding their children when they were 6 months, and at 12 months of age, 91.0% of children were up-to-date with their Well Baby Checks and with their immunizations. First 5 San Diego publishes its evaluation report annually and shares with the Commission, First 5 San Diego contractors, government agencies, community organizations and the public. The report is posted on the First 5 San Diego website and report findings are presented to the Commission. The evaluation results are reviewed throughout the year at meetings with the contractors. Results are used to identify successful practices and to implement strategies for continuous improvement. Data gathered are used by the First 5 staff for strategic planning and funding decisions and are available for use by other entities. During FY 2019-20, First 5 San Diego used evaluation data to secure philanthropic dollars to fund a report outlining a new mechanism for tracking preschool children into elementary school. First 5 San Diego anticipates this report will lay the foundation for a longitudinal study of quality preschool, whose results would significantly add to the state and national knowled

County Highlight

The COVID19 pandemic has presented unprecedented challenges for our staff, our community partners and the families First 5 San Diego serves. Our 2019-20 fiscal year was different from any previous year in our Commission's history. These last several months have been difficult and yet I have been inspired and encouraged by the way our community has rallied to support one another. When Governor Newsom issued stay at home orders in March, First 5 San Diego providers quickly pivoted to supporting families virtually. Maintaining these connections and supporting families through these most difficult times is critical for children's and caregivers' well-being. Despite the pandemic, during FY 2019-20, 42,046 San Diegans received direct services of which over 29,000 were under the age 5.

These services included quality preschool, parenting classes, health and dental services. Thousands of young children and their parents benefited from community-wide services such as the Kit for New Parents, a parent warm line, community health screenings and outreach. During FY2019-20, our Healthy Development Services (HDS) initiative celebrated its 15th year of identifying and treating children with mild to moderate developmental and social-emotional needs. This year also marks the culmination of our First 5 San Diego 2015-20 Strategic Plan. As we embark on our new FY 2020-25 Strategic Plan, we are embracing new strategic directions for our work: Resilient Families, Coordinated Systems of Care, Integrated Leadership, and Sustained Funding. First 5 San Diego is also pleased to announce a new quality early learning initiative, Learn Well. Learn Well builds upon the success of our 8-year Quality Preschool Initiative (QPI), which concluded this year. Learn Well will focus on strengthening existing early care and education system structures and expand the participation to providers serving infants and toddlers and aim to improve the skills of the adults working directly with children
