- Applying for First 5 Association Refugee Grant (up to \$750k) in partnership with Homeless Solutions and Equitable Communities (HSEC) and its subdivision, Office of Immigrant and Refugee Affairs (OIRA)
- Much discussion on the ARPA funding \$10M workforce development fund and \$2M infrastructure / childcare provider grant \$10M. Scheduled to present to the Board of Supervisors on 5/24.
- Working with Children First Collective, Housing and Community Development and CA Assemblymember Ward on upcoming legislation for co-locating childcare facilities to affordable housing.
- March of Dimes' March for Babies will be held on Saturday, May 21st.
- ED Arguilez and the Commissioners honored Finance Chair, Fred Baranowski, for his years of service to the commission, children and families. Mr. Baranowski is stepping down as Chair but will continue to serve as a valued Finance Committee member. Mr. Baranowski will receive a proclamation at the Board of Supervisors meeting on April 26, 2022.
