### F5 CA IMPACT Legacy Grant

#### Action

1

#### Overview:

In this last cycle of IMPACT funding, F5CA will promote conditions in state, regional, and local systems that implement QCC structures aligned to sustainability and a Collective Impact model. Objectives towards fulfilling the purpose of IMPACT Legacy include understanding and eliminating barriers to participation and prioritizing children's well-being, workforce engagement and well-being, family engagement, and multilingual learners.

First 5 San Diego has invested in the local QCC system, that is known as San Diego Quality Preschool Initiative since 2006 and continues to lead via the Learn Well Initiative that is supporting public and private providers countywide.

The funding for the IMPACT Legacy will allow for the continuation of the San Diego QCC consortium and Regional Hub efforts led by the San Diego County Office of Education (SDCOE), to expand access to the Quality Counts California (QCC) quality rating and improvement system (QRIS) and resources for center and homebased educators serving high-need communities and populations not already receiving quality support.

Funding is to be distributed as follows:

Figure 6: Lead Agency Eligibility Requirements for Fiscal Lead Agency (Grantee), Hub, and Local County Lead Agencies

Fiscal Lead Agency (Grantee)	Must be a First 5 County Commission.
Regional Hub Lead Agency	First right of refusal to regional Hub lead under IMPACT 2020. If that agency declines, any local public entity may apply.
Local County Lead Agency	First right of refusal to local county lead under IMPACT 2020.  If that agency declines, any local public entity may apply.

# First 5 CA Regional Technical Assistance for Home Visiting Coordination and Integration Grant

#### Overview:

The Commission approved the receipt of this funding at the February 9, 2023 meeting. The purpose of this grant is to enable San Diego to continue the work creating a sustainable, unified system that provides home visiting services to support family well-being and maximize available funding to serve more families.

This grant is intended to be a continuation of the prior funding received from F5CA work that has been led by the American Academy of Pediatrics (AAP) countywide. Additionally, the grant application identified the First 5 Center for Children's Policy (the Center) as a funded partner to lead a HV systems mapping effort that includes cost modeling of HV programs, fiscal mapping and data stratification. The Center is a partner with F5CA and County commissions statewide in supporting and leading systems change efforts on behalf of the statewide network, as well as developing program briefs and evaluation efforts that First 5s statewide can learn from and advise program improvement and future program development.

Additionally, there are funds allocated to support First 5 San Diego grant oversight, as well as contracting with the YMCA Childcare Resource Services (CRS) as the newest certified site for the Healthy Families America to support centralized intake services countywide.
