2 Action	Approval of a Sole Source Contract with Persimmony International for the CMEDS Data System Supporting Document Overview: On April 16, 2020, a sole source amendment with Persimmony International for the Contract Management and Evaluation Data System (CMEDS) was approved by the Commission to continue providing the database that maintains all data that is collected and reported on for all funded programs. This contract amendment was approved for 5 years through June 30, 2025. CMEDS has been customized for each of the Commission's programs and supports the tracking of program participants	
	served, demographic data, outcome data and the specific indicators and targets contained in the Commission's Strategic Plan. The data system supports both contract monitoring and evaluation and allows First 5 San Diego to meet First 5 California's reporting requirements and provides access to meaningful data for program evaluation to the community and stakeholders. Action	 Approval of a Sole Source Contract with the San Diego County Office of Education (SDCOE) for the Learn Well Initiative Supporting Documents Overview: In 2020, a sole source contract with SDCOE was approved by the Commission to lead the Learn Well Initiative. This contract was approved for 5 years through June 30, 2025. The Learning goal outlined in the new strategic plan focused on strengthening the system to improve the quality of early care and education is aligned with the Learn Well Initiative. Learn Well continues to build on the foundational work that began in 2006 and supports the greater San Diego Quality Preschool Initiative quality early learning system. As the lead agency for the local implementation of Quality Counts California (QCC)—a statewide initiative aimed at strengthening California's early learning and care system— SDCOE has made significant strides in prioritizing communities with the greatest needs providing access to essential tools and resources for ELC administrators and teachers, advancing their commitment to delivering high-quality early learning and care. As the local consortia lead, SDCOE also leverages funding from the CA Department of Education (CDE) and First 5 CA Commission to support the local First 5 San Diego quality early care and education early education system. Staff Recommendation: Find that the proposed First 5 San Diego Learn Well Initiative is consistent with the Commission's Strategic Plan, furthers the quality enhancement of early education within the County and provides a public benefit. Approve a five-year sole source contract with SDCOE for FY 2025-30. Authorize the Executive Director or designee to negotiate and execute a sole source contract with SDCOE. In FY 2025, the Commissions revenue will be reduced by approximately \$13M and the available program funding will be at \$20.5M each year.
