#### 6. Executive Director Report

Executive Director Arguilez provided an update on the following issues affecting the Commission:

- ED Arguilez shared with the Committee members that First 5 CA provided revised revenue projections on April 17, 2025 that demonstrate a reduction of approximately \$1.8M per year in FY24/25 and a reduction each year of approximately \$1.9M to 1.6M through FY28-29.
- As a result of this update, the Commissions Financial Spending plan reflects a conversative plan to ensure that we can sustain our commitments.
- ED Arguilez requested that the committee members come prepared with some candidate recommendations from the community with an accounting and/or finance background that can be a possible new member of the Finance Committee. This will be discussed at the September 18<sup>th</sup> meeting.
