This letter informs counties of the augmentation to the Fiscal Year (FY) 2025-26 California Work Opportunity and Responsibility to Kids (CalWORKs) Home Visiting Program (HVP) funding. The augmentation of approximately \$20.2 million in federal Temporary Assistance for Needy Families funds and General Fund is available based on updates to FY 2025-26 in the 2026-27 Governor's Budget.

As shown in the attachment, the California Department of Social Services, in consultation with the County Welfare Directors Association, has distributed the CalWORKs HVP augmentation based on each participating county's percentage of the total FY 2025-26 allocation provided in [CFL 25/26-24](#), with an update to the methodology to incorporate September 2024 adjustment claims as reported in the County Expense Claim Reporting Information System.
